## The Eth2 upgrades



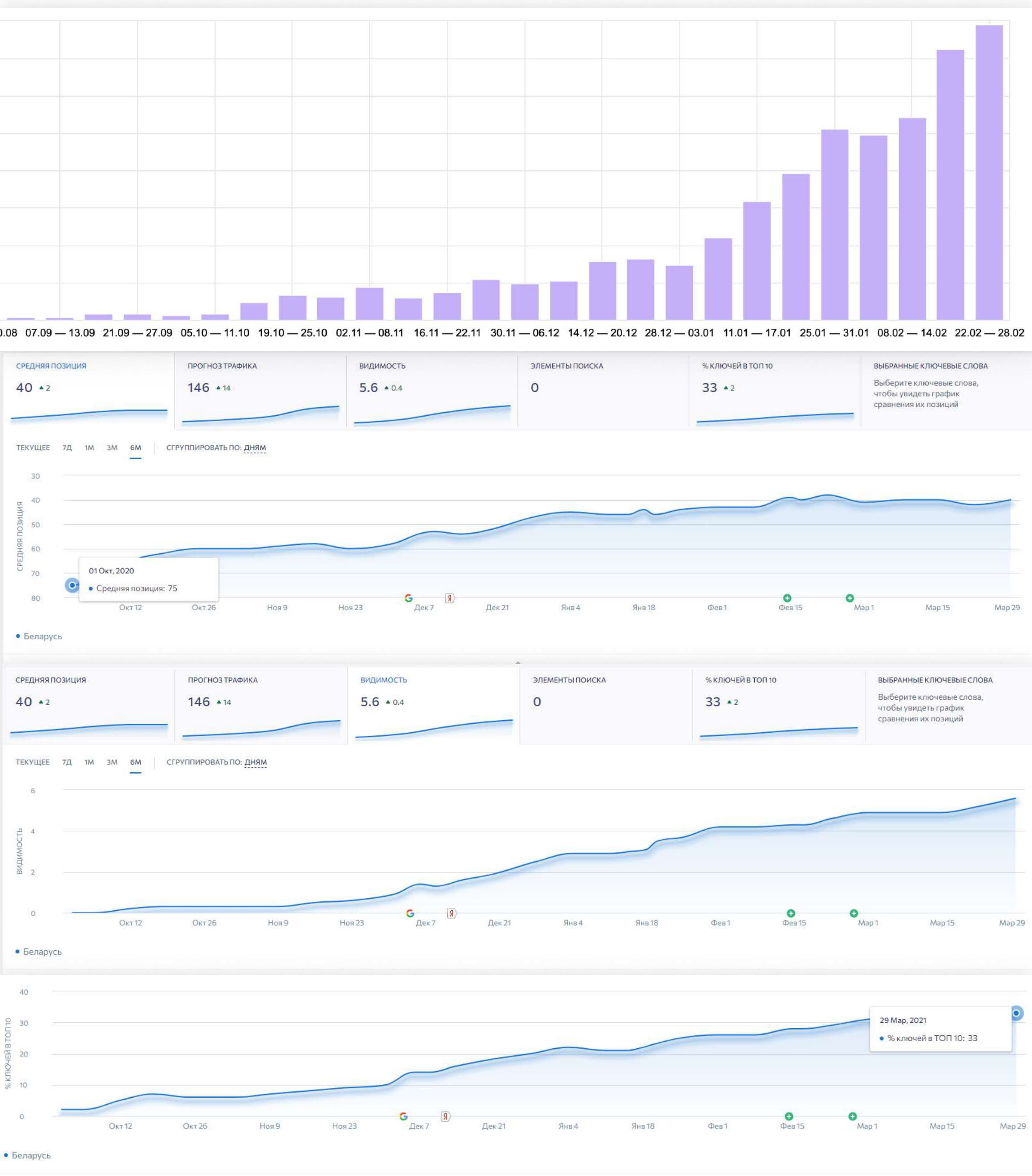

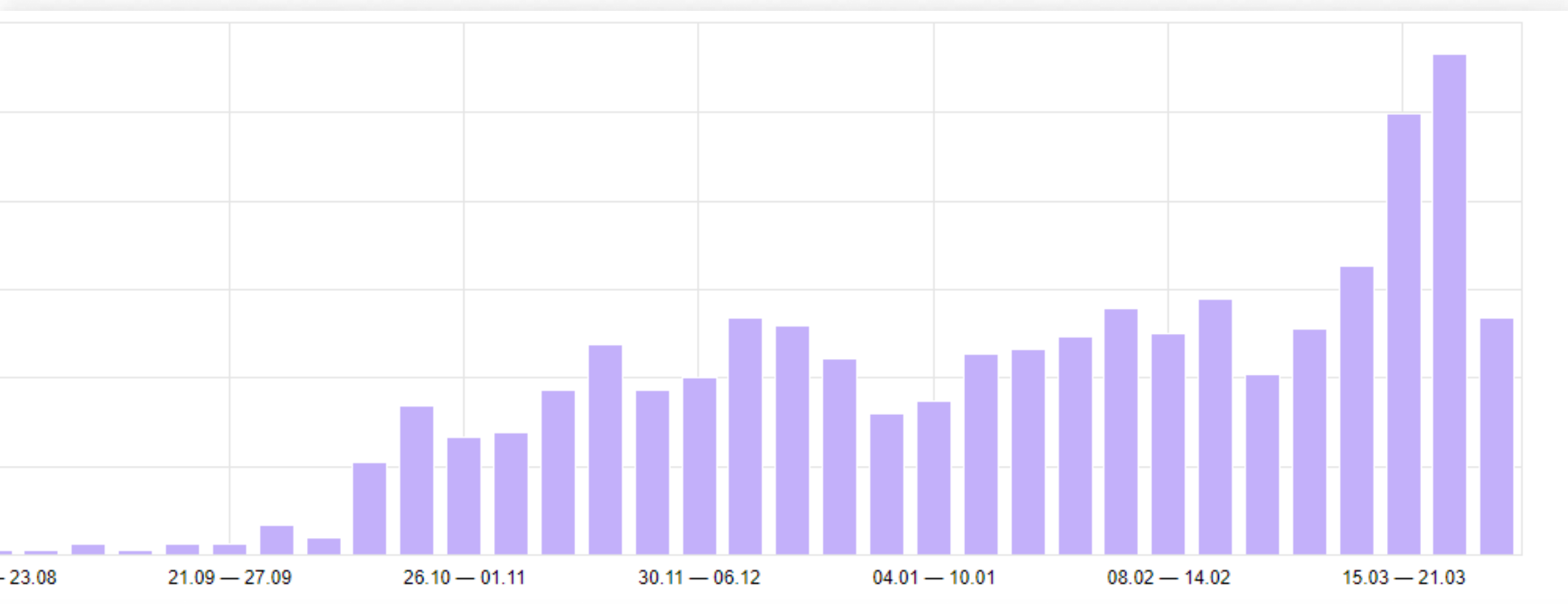


Traffic at the start of work - 5 visitors per week.

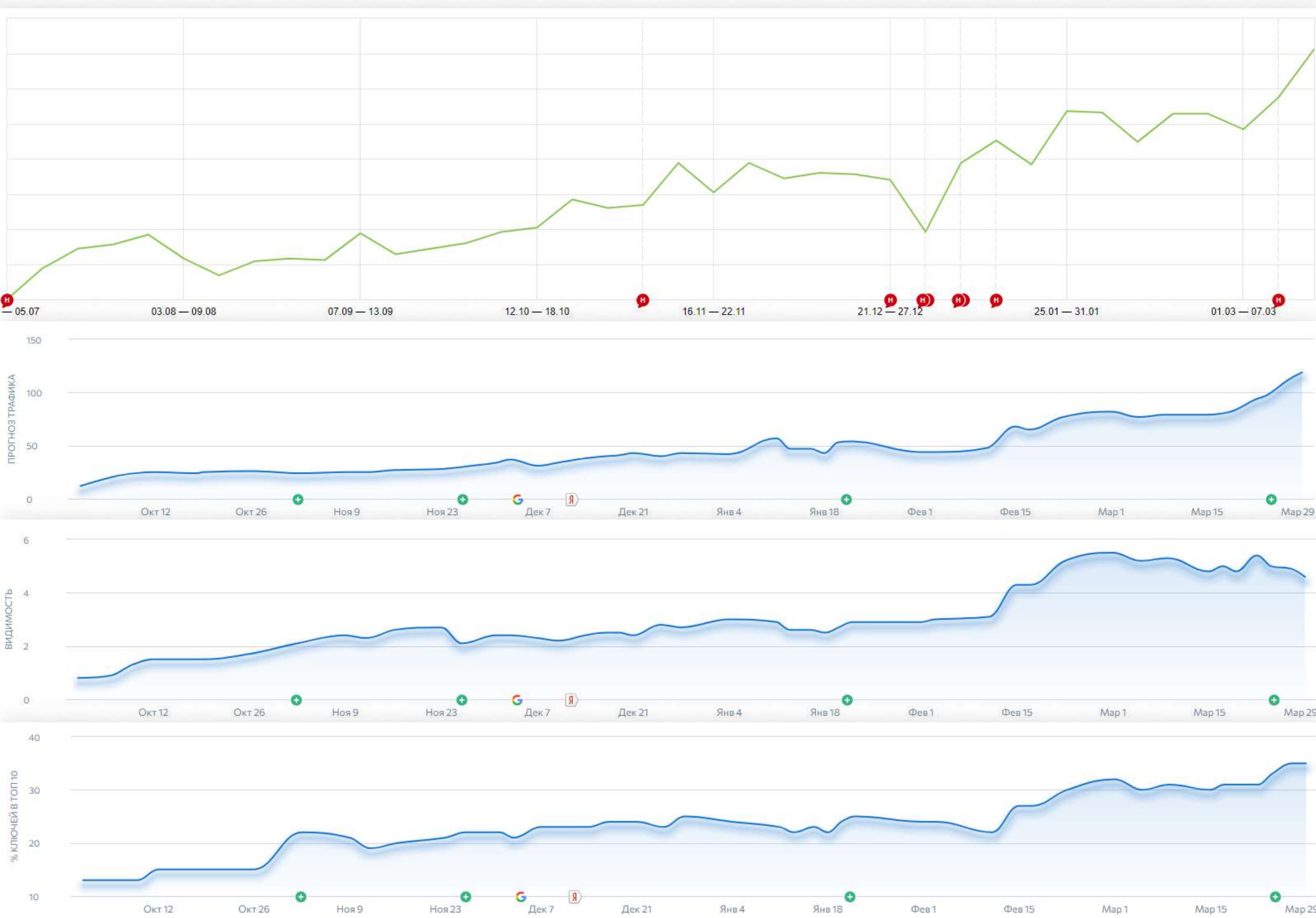
